PyCon 2012 was held March 7 - March 15 in Santa Clara, CA at the Hyatt Regency Santa Clara and the Santa Clara Convention Center. Two days of Python tutorials and a Python Language Summit preceded the three day core conference, and four days of programming sprints followed. This conference draws Python developers world-wide, providing them opportunities to learn about significant advances in the Python Community and to meet and network with fellow developers. Education sessions are presented on multiple tracks to address topics of interest at all levels, from object-oriented programming to sophisticated web development and scientific computation.

Sponsored Python conferences world-wide. Provided grants to assist with the funding of local Python conferences worldwide. The following major conferences were partially sponsored: PyCon Australia, Kiwi Pycon, PyCamp Argentina, PyCon Philippines, ScyPy 2012, EuroPython 2012, PyCon India, PyOhio, PyCon ZA, PyCon UK, PyCon Canada, PyData NYC, RuPy 2012, PyCon Brazil 2012, PyArkansas. The Foundation also sponsored a number of small Python programming "sprints". Sponsorship is granted based on the number of conference attendees.
